

And if intellectual property rights are the material and moral rights that are decided upon by the owner of thought and creativity, then in this sense they apply to the rights of the owners of educational content over the educational services they provide, whatever their type or method of expression. Therefore, we will address, through this national forum, the topic of "Intellectual Property Rights in the E-learning Environment," which is a topic that gains a degree of importance due to legal, jurisprudential, and technical considerations.

From this standpoint comes the importance of this topic, through which we shed light on the laws and systems of intellectual property rights for e-learning media as protected works, and the rights that can be decided for educational institutions on these works, as well as how to deal with problems of electronic publishing and dealing with issues of intellectual piracy of educational software electronic, as well as the liability of educational institutions arising from infringement of intellectual property rights.

From here, this forum aims to answer the following questions:

What are protected works in the field of e-learning?

To what extent are the faculty and students aware of the intellectual property rights of electronic educational materials? What is their view of intellectual property rights and their violations?

What is the role of the university in protecting the intellectual property rights of electronic educational materials?

What are the responsibilities resulting from the violation of intellectual property rights and theft of digital works?

It can be said that among the relevant laws are those related to electronic transactions, consumer protection and the protection of intellectual property rights, all of which can help establish the rights and duties of those in charge of providing the new educational services as well as the beneficiaries thereof.

- 3- Reviewing initiatives and plans to control educational content supporting e-learning programs, including plans and programs supporting this program, with a focus on the reality of Algerian universities.
- 4- Mechanisms and procedures aimed at protecting intellectual property rights for various infringements and the penalties prescribed for that.

Themes of the National Forum

The first axis: e-learning systems and their components (the university and the trend towards providing digital content and e-learning programs).

The second axis: the Algerian experience in the field of managing e-learning and distance education - reality and challenges -

The third axis: educational institutions' rights over digital works (educational institutions' ownership of works and the right to use them for e-learning purposes).

Fourth Axis: Responsibility of educational institutions for infringement of intellectual property rights (civil liability and penal liability "protection mechanisms and established penalties")

The intervention should not have been published, submitted for publication, or previously participated in in another scientific event.

The intervention includes a summary and keywords in the language of the article and in another language, provided that the number of pages of the intervention is between 10 to 20 pages.
