### **The problem**

Algeria has ratified a various international conventions and charters, which devote rules and fundamental principles aimed to find the alternatives of the penalties private liberty, and to make the application of penalties to protect society, through the re-education and social reintegration of prisoners in the penitentiary establishments.

The objective of the application of the judicial judgment depriving of liberty is no limited to placing the convicted person in a closed environment for repressive, but the objective is to re-educate him and reintegrate him into society to avoid his return to criminality.

For these reasons, Algeria look for to find the alternatives of the penalties private liberty, and these were provided in law N 05-04, relating to the prison organization and social reintegration of prisoners, amended and completed, as well as regulatory texts.

The alternatives of the penalties private liberty are numerous and varied, someone applied inside the closed environment of the penitentiary establishments and others outside, in the open environment, and all have an effective impact on rationalizing expenses of the penitentiary establishments.

This national conference aims to study the instruments of re-education of prisoners in the closed environment of the penitentiary establishments in Algeria, and to research the void and obstacles, which prevent the application of the legal texts regulating these instruments. The aim of developing them and creating alternatives and other instruments for the re-education of prisoners, in order to achieve the objectives that the Algerian State look for to develop the justice sector, and to rationalize the expenses of the penitentiary establishments to advance the economic sectors.
