Preamble to the Conference:

The significance of human rights has garnered substantial attention from the international community, manifesting in the formulation of numerous international charters and agreements that encapsulate states' commitment to safeguarding individual privacy. Noteworthy among these are the Universal Declaration of Human Rights and the International Covenant on Civil and Political Rights, which assert: "No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks." Additionally, various conferences have advocated for the preservation of privacy. Nevertheless, it is observed that these agreements and conferences, while addressing traditional forms of private life, have not adequately considered the protection of privacy in the context of the emergence and evolution of information technology and its implications for this right. Consequently, international and regional discussions have been initiated, leading to the emergence of diverse international trends, including resolutions from the United Nations General Assembly and contributions from the Human Rights Council. These developments align with a prevailing global consensus that the evolving legal landscape necessitates the respect and protection of human rights in light of contemporary digital challenges, particularly regarding the advancement of artificial intelligence systems. This discourse must encompass the legal, technical, and regulatory challenges related to cybersecurity at global, regional, and national levels. Furthermore, it posits that new digital rights are congruent with the rights traditionally enjoyed by individuals and therefore warrant protection within the digital realm.

Consequently, both international and national initiatives are mobilized to mitigate risks posed to human rights by fostering cooperation and partnership aimed at organizing the future of human rights amid significant digital advancements. Achieving this objective requires the enhancement of the legal framework for human rights protection and the restructuring of the digital system to promote international transparency while leveraging technology for its beneficial aspects. Furthermore, it is essential to ensure user safety from cybercrimes and to safeguard their data from breaches through the establishment of clear guidelines delineating the obligations of states and the responsibilities of corporations, encouraging the latter to uphold and advance human rights rather than undermine or violate them.

The Problem of the Conference:

How can human rights be effectively safeguarded in light of the accelerating advancements in digital systems? What challenges hinder the protection of human rights while concurrently adapting to digital developments?

Conference Topics:

First Axis: The Conceptual Framework of Artificial Intelligence and Human Rights.

Second Axis: The Positive and Negative Effects of Digital Developments on Human Rights.

Third Axis: Challenges of Protecting Human Rights in the Digital Space and in the Context of Artificial Intelligence Systems.

Fourth Axis: International Cooperation and the Position of the Algerian Legislator on Safeguarding Human Rights from the Risks of Artificial Intelligence.

Participation Conditions:

- * The topic must be pertinent to one of the forum topics.
- * The proposed intervention must not have been previously published or presented.
- * The length of the intervention must not exceed 20 pages and must not be less than 10 pages.
- * For interventions in Arabic, the Simplified Arabic 16 font is utilized for the text and 12 for references; for interventions in foreign languages, the Times New Roman 12 font is applied for the text and 10 for references.
- * Footnotes must be positioned at the end of each page.
- * Both individual and joint bilateral interventions are accepted in Arabic, English, and French.
