#### The Issue of the Study Day

Biodiversity around the world is facing increasing threats due to escalating environmental pressures and accelerated human activities, which range from the overexploitation of natural resources, climate change, pollution, and urban expansion, to the spread of invasive species. Developing countries are among the most affected, despite being among the richest regions in biodiversity, which highlights the need for an effective and balanced legal framework to safeguard this vital natural heritage.

The international community has established a set of international agreements and global declarations aimed at conserving biodiversity, most notably the Convention on Biological Diversity (1992), in addition to the Cartagena Protocol on Biosafety and the Nagoya Protocol on Access and Benefit-Sharing, which impose multiple obligations on states to enhance the protection of genetic resources and the associated traditional knowledge.

However, developing countries, including Algeria, face several difficulties in fulfilling these obligations, due to economic constraints, weak institutional capacities, limited access to technology, and challenges related to national sovereignty over natural resources in the face of transboundary threats. There is a pressing need to strengthen national legislative frameworks, ensure the effectiveness of environmental governance mechanisms, and enhance international cooperation to ensure the sustainable use of biodiversity. The organization of this study day comes within the context of growing interest in these issues and aims to shed light on the **legal mechanisms available to protect biodiversity in developing countries**, while identifying the challenges facing their implementation and proposing solutions capable of strengthening effective legal protection.

#### **Problematic:**

To what extent are the national and international legal mechanisms adopted to protect biodiversity in developing countries effective, in light of the economic, institutional, and technological challenges these countries face?

And what are the appropriate means to enhance the effectiveness of these mechanisms and ensure the sustainable use of biological resources in a way that balances conservation requirements with development needs?

#### **Objectives**

- Analyze the international and regional legal framework for biodiversity protection.
- Diagnose the status of national legislation in developing countries and its compatibility with international obligations.
- Highlight the practical challenges (economic, technical, institutional) that hinder legal protection efforts.
- Discuss the role of traditional knowledge and local communities in biodiversity conservation.

- Explore mechanisms of international cooperation and technology transfer to support biodiversity protection in developing countries.
- Propose legal and institutional recommendations to strengthen national legislation and ensure the sustainable use of biological resources.
- Promote scientific dialogue and exchange of experiences among researchers and practitioners in the field.
