Preamble:

The purpose of creating criminal justice in général is to achieve justice and the rule of Law instead of Revenge and abuse , Dedicating criminal justice through international criminal justice bodies especially in the most serious crimes, this is exemplified by the Rome statute of the international criminal court by delining the subject matter jurisdiction ensure that the perpetrators of these crimes do not go unpunished .

The crime of international terrorism has occupied global and local public opinion , including researchers and specialists. with the increase in its dangers at the international level, it has occupied the center stage among contemporary global issues and has been a focus in the discourse of the international community without exception especially after the events of september 11.2001, where received wide attention in confronting it.

Although terrorist act reached their climax in conjunction With the preparations for the establishment of the international criminal court and the condemnation of it by the international community . The jurisdiction of the international court of international terrorism did not fall within its substantive jurisdiction .

From here , the problem of the National form emerges through the search for the various obstacles that prevented the inclusion of international terrorism, within the exclusive jurisdiction of the international criminal court and the extent to which the crime of international terrorisms can be included in the circle of crimes under consideration by the court that threaten international peace and security .
