Problematic of the Study Day

Recently, societies have witnessed the emergence of many new crimes, a result of the social and economic accumulations within them. This has led offenders to pursue quick profits, regardless of how they achieve them, even at the expense of human integrity. They exploit people in the most brutal ways, without any regard for the sanctity of the human being.

Human trafficking is one of the most significant crimes that affect a person's being and humanity, and it has spread widely in Algerian society due to the enormous profits this trade generates. This is particularly true with the technological advancements across all fields, which in turn have led to the commission of this crime through modern means and methods, making it difficult to detect and pursue the perpetrators.

This has prompted the Algerian legislator to keep pace with this development by addressing this crime through the enactment of Law 23/04. Through this law, the Algerian legislator sought to encompass all criminal behaviors associated with this crime and to adopt mechanisms and

measures aimed at combating and reducing it.

From here, we can pose the following question:

What are the penal mechanisms adopted by the Algerian legislator to suppress human trafficking?

The objectives of the study day
